## 1. The Promoter

The promoter is: Pension Services Corporation Limited of 14 Cornhill, London, EC3V 3ND.

## 2. The competition

2.1 The title of the competition is "Take your penguin on holiday".

2.2 Win a prize by:

- (a) following @PensionCorp on Twitter;
- (b) tweeting a summer themed photo of a penguin with no identifiable people visible, hashtag #PICpenguinsummer to @PensionCorp;
- (c) including a description of the photo in our tweet

## 3. How to enter

3.1 The competition will run from 9am BST on 1 August 2019 (the "Opening Date") to 5pm BST on 15 September 2019 (the "**Closing Date**") inclusive.

3.2 All competition entries must be received by the Promoter at @PensionCorp by no later than 5pm BST on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.

3.3 To enter the competition:

- (a) following @PensionCorp on Twitter;
- (b) tweeting a summer themed photo of a penguin with no identifiable people visible, hashtag #PICpenguinsummer to @PensionCorp;
- (c) including a description of the photo in our tweet

3.4 No purchase necessary and there is no charge.

3.5 The Promoter will not accept:

- (a) responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
- (b) proof of posting or transmission as proof of receipt of entry to the competition.

3.6 By submitting a competition entry, you are agreeing to be bound by these terms and conditions.

3.8 The competition entries will be judged by a panel of two judges based on the composition of the picture and the most apt and original description. The decision of the panel of judges (acting reasonably) will be final.

3.9 The Promoter will send the full names of the judges to anyone who writes within one month after the Closing Date of the competition requesting details of the judges and who encloses a self-addressed envelope to the following address; Pension Services Corporation Limited, 14 Cornhill, London, EC3V 3ND

#### **4. Eligibility**

4.1 The competition is only open to all residents in the UK aged 18 years or over, except:

- (a) employees of the Promoter or its holding or subsidiary companies;
- (b) employees of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the competition or its administration; or
- (c) members of the immediate families or households of (a) and (b) above.

4.2 In entering the competition, you confirm that you are eligible to do so and eligible to claim any prize you may win. The Promoter may require you to provide proof that you are eligible to enter the competition.

4.3 The Promoter will not accept competition entries that are:

- (a) automatically generated by computer;
- (b) completed by third parties or in bulk;
- (c) illegible, have been altered, reconstructed, forged or tampered with;
- (d) photocopies and not originals;
- (e) illegal or vulgar or feature any identifiable people; or
- (f) incomplete.

4.4 You may enter as many photos as you wish but each person will only be eligible for one prize.

4.5 The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.

#### **5. The prize**

5.1 The prizes are;

- (a) 1st: A voucher for a midweek overnight stay for two at the Grove, Hertfordshire with £100 spending money.
- (b) 2nd: £100 Amazon gift card
- (c) 3rd: £50 Amazon gift card.

5.2 The overnight stay is for two people for one night at the Grove Hertfordshire between 27/09/2019 and 27/07/2020. The stay includes a buffet breakfast the morning after and full use of the leisure facilities including Sequoia spa. The voucher is valid for stays on Sunday – Thursday, is non-refundable and must be redeemed in full, in one transaction. Advance reservations are recommended. Vouchers may not be valid on selected dates such as Christmas, New Year, Bank Holiday weekends and Easter. Friday and Saturday stays are available at a supplement. Please note a discretionary 12.5% service charge will be added to your bill for any additional food or beverage spend. The prize does not include travel insurance, the cost of transfers to and from airports or stations, food and drink, spending money, tax or personal expenses. Any other costs incurred in addition to those set out above and that are incidental to the fulfilment of the prize are the responsibility of the winner(s). We will send a cheque for £100 with the voucher.

5.3 The Promoter reserves the right to substitute the prize with a prize of equal or greater value.

5.4 The prize is not negotiable or transferable.

## **6. Winners**

6.1 The decision of the judges nominated by the Promoter is final and no correspondence or discussion will be entered into.

6.2 The Promoter will contact the winner personally as soon as practicable after the Announcement Date, using the Direct Message facility on Twitter and tweeting @ the winner.

6.3 The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation the Promoter will publish the twitter address of major prize winners and their winning entries via Twitter on the [@PensionCorp](https://twitter.com/PensionCorp) twitter account on 17/09/2019 (Announcement Date).

6.4 If you object to any or all of your twitter address and winning entry being published or made available, please contact the Promoter using the address in clause 1 or by twitter [@PensionCorp](https://twitter.com/PensionCorp). In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.

## **7. Claiming the prize**

- 7.1 If you are the winner of the prize, you will have 14 of days from the Announcement Date to claim the prize by responding to the Direct Message with your full name and address for the prize to be sent to. If you do not claim the prize by this date, your claim will become invalid.
- 7.2 The prize may not be claimed by a third party on your behalf.
- 7.3 The Promoter will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed their prize within 14 of days of the Announcement Date, the Promoter reserves the right to offer the prize to the next winning entrant selected from the entries that were received before the Closing Date.
- 7.4 The Promoter does not accept any responsibility if you are not able to take up the prize.

## **8. Limitation of liability**

Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

## **9. Ownership of competition entries and intellectual property rights**

- 9.1 The Promoter does not claim any rights of ownership in your competition entry.
- 9.2 You agree that the Promoter may, but is not required to, make your entry available on its website <https://www.pensioncorporation.com/> and any other media, whether now known or invented in the future, and in connection with any publicity of the competition. - 11.2 The Promoter reserves the right to hold void, suspend, cancel, or amend the prize competition where it becomes necessary to do so.
- 11.3 These terms and conditions shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
